

# IRS SAYS, "NO TAX REFUNDS" UNTIL MARCH 1<sup>ST</sup>!

March 1st may be the day that the majority of tax refunds will be received by taxpayers in 2019. The question is WHY?

The answer is IDENTITY FRAUD. Tax Identity Fraud has become more and more of an issue for the IRS in recent years. In fact, the IRS states that they received over 490,000 tax fraud complaints in 2018 alone! In reaction to this ever-growing problem,

the IRS has decided to freeze all refunds for those that claim the following 2 tax credits and will not release them until February 15th, 2018 even if you file in January:

#1 – Earned Income Credit

#2 – Additional Child Tax Credit

The IRS feels this will give them more time to match W2's that are being sent

to them earlier this year to the actual person instead of just processing whatever is filed. They are in high hopes that this delay in processing certain types of returns will reduce the amount of fraudulent refunds going out to the wrong people.

What does this mean for you? Well, if you do not file either of the above credits on your tax return then you have no worries, the IRS will process

your return as normal which is usually about 1-2 weeks after acceptance. This means your refund could be in by the end of January if you file when E-file officially opens. However, for those that do need to file these credits, the IRS will not process your return until February 15th. This means that if you file in January, you may not see your refund until March 1st or LATER!
